Key Roles and Responsibilities

Housekeeping

- Maintain high standards of cleanliness within your assigned area at all times.
- Complete a range of routine cleaning jobs using the systems of work provided.
- Organise your own daily cleaning tasks in line with cleaning schedules.
- Launder hospice-own bedding and patients' clothes as required.
- Support regular, annual and ad-hoc deep cleans and as required.

Customer Service

- Be a welcoming and friendly presence within all areas that you work within.
- Support all colleagues to provide a seamless service which may include interacting with patients, families, visitors while carrying out your housekeeping role, informing clinical teams of activities and observations where clinical support is required, providing a safe and efficient working space for colleagues, and identifying additional housekeeping tasks required as a result of operational or patient activity.

Infection control

- Adhere to any infection prevention requirements and provide information, guidance and support to colleagues to enable them to do the same.
- Follow appropriate PPE guidance and requirements.
- Take part in COVID or other infection testing programmes as required and in line with guidance.
- Carry out required legionella prevention measures as scheduled.

Infection Prevention

All Rowcroft Hospice employees in both clinical and non-clinical roles are required to adhere to the Infection Prevention and Control Policies and make every effort to maintain high standards of infection control at all times to reduce the burden of Healthcare Associated Infections including MRSA.

- To decontaminate your hands prior to and after direct patient care or contact with the patient's surroundings;
- To take part in mandatory infection control training provided;
- To responsibly manage your own infections (other than common colds and illness) that may be transmittable to patients, including to contact Occupational Health for guidance.
